Refuge staff is working with the City of Gaston to keep them informed about the upcoming levy repairs and discovered that seasonal flooding of the Gaston baseball field is a major concern for the local population. Refuge staff is trying to find a solution to keep the water off the field without impacting Wapato Lake's hydrology.

CTGR: The Refuge was directed to incorporate ecological knowledge of indigenous communities into their planning. Staff is holding monthly meetings with representatives of the Confederated Tribes of the Grande Ronde to discuss prairie restoration.
