Reports

1. President – Cheryl Hart

Last week an aide to Senator Merkley (Chair of Interior Appropriations), Mitra Anoushiravani, visited the Refuge. She was very enthusiastic and we hope she will facilitate a visit later this year by the Senator himself, either to Tualatin NWR, or to Wapato Lake NWR.

2. Executive Director – Bonnie Anderson

- Bella Padgett was hired as the new Habitat Restoration Specialist. She will work parttime until the end of July, and start full time in August. Bonnie will invite her to attend next month's board meeting.
- Carly has agreed to continue working 40 hours/month to finish projects and to help train Bella.
- The Beer Festival contract is signed. Planning meetings are ongoing. The Festival will take place August 5-6.
- The TREE grant application will be submitted later this week.
- Sherwood Rotary invited us to apply for \$1,000 for the Youth Summit.

3. Refuge update:

a. Rebecca

- Refuge staff is continuing to meet with the Gaston City Council about Wapato Lake restoration and repair of the embankment. A field staffer for Senator Widen attended the last meeting.
- Tonquin Quarry: last week Refuge staff was notified that a judge upheld the permit, ignoring or dismissing our findings of facts and accepting the Quarry's statement that their operation will have no impact on the wetlands. The Service is filing additional objections, which are due June 1. Meanwhile the Quarry still needs a permit under Section 404 of the Clean Water Act. Senator Merkley is aware of the issue, thanks to our letter. Western River continues to be interested in a potential acquisition of the property.
- The outside restrooms are out of order.

b. Todd

The current exhibit in the Visitor Center is 15 years old and needs to be overhauled to reflect the changes that took place on the Refuge in the meantime. The planning process is expected to extend into 2024. It will be as inclusive and empowering as possible to a broad scope of the community. The Friends need to have a conversation about how, and to what degree we wish to be involved in this process.

c. Natalie

Natalie reminded us that depending on the circumstances, we may act as volunteers either of the Service, or of the Friends. Please refer to the latest issue of the Volunteer Newsletter.
